Professor S.B.Ghosh, Life member of Indian Library Association, retired from Indira Gandhi National Open University (IGNOU) is no more. He breathed his last on 14.11.2018. Prof. Ghosh worked in IGNOU from 1998 to 2007 till his retirement. Prior to that, he worked in National Institute of Science Communication and Information Resources (NISCAIR), New Delhi. Prof. Ghosh also worked as Librarian, Geological Survey of India. He played an active role in the profession having been associated with professional associations in various capacities. He was also associated with Annals of Library and Information Studies as a member of its editorial board. He was very active after retirement and was teaching in various universities in Kolkata as visiting professor. ILA Council is deeply saddened by the news of his death and we pray for the strength to his family to bear this loss.
